- The cost for exceeding DOIs registered in the current year is invoiced at the beginning of the following year at the price per unit of the DOI Bracket chosen for the current year. If more convenient, customers will be upgraded to the next upwards DOI
- Bracket without other extra costs than the balance between the two DOI Brackets.
- Discounts apply to backlist content, depending on the number of requested DOIs.
